- □ Must be a Maldivian woman, 25 years & above and based in the Maldives.
- □ Must be an entrepreneur, or a professional in Business & Finance; having served at least five years in a key leadership position.
- □ Must have a favourable regulatory compliant history.
- □ Must not have been convicted of a crime.

Additionally, in determining whether the candidate has made a significant economic and societal impact with her leadership and experience, the following criteria are also to be considered as relevant. **Please provide details with evidence for Criteria 1-7 below:** 

- 1. Number of direct beneficiaries or employees served.
- Number of organizations the candidate has been professionally associated with and in what capacity, in the past five years or more.
- 3. The candidate's educational aualifications and professional desianations.
