7. WOB Distinction & Award for Best Woman Chairperson in the Public Sector

The prestigious award of the Best Woman Chairperson honours the most well formed traits that achieve a mutual understanding within a board or council. In this award, we recognize the incomparable strength and wisdom of these individuals. (Open to Public Sector Companies)

8. WOB Distinction & Award for Women in Islamic Finance

Women on Boards (WOB) of Maldives introduces the world's first Islamic finance awards for exclusive recognition of women. Award Categories

8.1 Institutions

Best Institution for Advocating Women in Islamic Finance:

Any institution which believes that they have contributed to increase/recognize female talent in Islamic finance industry can be nominated for this category and the judges panel will decide based on the magnitude of the contribution made to the Islamic finance industry. Furthermore, any institution that has used innovation to cater economic empowerment of women via Islamic finance will be recognized under this category.

8.2 Individuals

8.2.1 <u>Life Time Achievement Award for Outstanding Performance in Islamic</u> <u>Finance Industry</u>

Winners for this category will be selected by the WOB Executive Board.



8.2.2 Islamic Finance Young Professional Award

Women who have contributed 5 or more years to the Islamic finance industry who is below the age of 35 can be nominated to this category and evaluation will be made on the magnitude of the contribution they have made to the Islamic finance industry.

8.2.3. Leading Women in Islamic Finance Awards:

Women who have contributed to more than 15 years of service in any of the following sector can be nominated to the award for:

- ➢ Takaful sector
- Islamic banking sector
- Islamic capital market sector
- Research/News/Marketing
- ➤ Teaching

8.2.4 Mentorship Award for Developing Female Talent Pool in Islamic Finance

Any male/female who has contributed to groom female talent can be nominated to this category. His/her contribution must be proved with testimony of those females who have been groomed or any other supporting documents shall be submitted to prove it.
